Agreement:

- The above mentioned dog is sold as a family pet only and cannot be bred under this contract _____(Buyer Initial)
- Puppy is to be paid in full by 7 weeks of age unless other arrangements have been made _____(Buyer Initial)
- We do not sell puppies on a trail basis! All "normal" puppy behaviors (chewing, nipping, biting, digging, jumping, running, barking, and or periods of high energy) are not a fault with the dog. With proper training, maturity of the dog, and commitment from Buyer, undesirable behaviors can be corrected. _____(Buyer Initial)
- Buyer agrees to never take a Grace Goldens dog to a shelter or to re-sale to any type of pet store. _____(Buyer Initial)
- If you can no longer care for your Grace Goldens, we will gladly assist in re-homing your dog. However, to place in a suitable home, it may take up to 4 months and no refund will be offered. _____(Buyer Initial)
- Buyer authorizes Seller to use any and all still photography and/or video recordings provided by buyer, regardless of whether the content includes buyer's image or likeness, for advertising and other purposes. _____(Buyer Initial)
- In the event of a dispute, the buyer and seller agree to not publish or communicate the existence or content of such dispute in any way, including any publication in social media, without the other parties consent. _____(Buyer Initial)

Seller Representations:

The following conditions apply to the sale of the aforementioned dog:

1. The seller guarantees the puppy is in good health, is up-to-date on immunizations appropriate for the puppy's age and has had appropriate worming at the time the Buyer takes possession.
2. The Seller provides a two year health warranty from the date of birth against any debilitating genetic defects. Genetic defects that qualify for reimbursement are those related to hip, heart, elbow, or life threatening issues. In the event puppy exhibits symptoms of a suspected genetic defect, the buyer must supply any requested veterinary records to the Seller and those records must provide proof of genetic defects. _____(Buyer Initial) The Seller will be given the opportunity to take said dog to a licensed veterinarian of its choosing for an examination before consideration of refund be given. Reimbursement for genetic defects is limited to the total amount paid for puppy minus the \$500 deposit. Please note that OFA must diagnose Hip and or Elbow Dysplasia (Buyer's expense). After all required testing has been completed and appropriate evaluation, reimbursement will be sent to you.
3. The Seller's warranty does not include viral illnesses, infections, improper bites, hernias, hypoglycemia, any type of worms, Guardia, or Coccidia. In addition, this warranty does not include any illness due to the ingestion of foreign objects, food, chemicals or physical injury.
4. The Seller agrees that umbilical hernia repair and Cryptorchidism (retained testicles) will be reimbursed up to \$150. In these rare instances, medical records must be supplied to Seller with the amount charged. This is a common procedure and will be corrected during spay/neutered (Buyer's expense).
5. The Seller agrees to provide a microchip that has been implanted in the puppy by a licensed veterinarian.
6. The Seller does not guarantee this dog will not shed or cause an allergic reaction. Buyer understands that Seller's prediction of coat type, height, and weight at adulthood are estimates only. _____(Buyer Initial)
7. No warranties or guarantees, expressed or implied, are made under this contract except as stated.
8. The warranty is non-transferable.

Buyer Representations:

1. The Buyer agrees to pay the Seller a total sum of \$ _____. This fee does not include transporting the puppy.
2. The Buyer has Four business days from the date of purchase _____ to take puppy to a licensed veterinarian for an examination. Any request to return the dog to the Seller must be made within this time period and must be accompanied by a written statement from a veterinarian describing all problems found. Failure to have the puppy examined within 4 days of purchase voids the health warranty. _____(Buyer Initial)

3. The Buyer agrees to house their Grace Golden indoors.
4. The Buyer has ONE year from the date of birth to have puppy spayed or neutered. A copy of the procedure from licensed veterinarian must be sent to the Seller. Failure to comply with our strict spay/neuter agreement will void health warranty.
_____(Buyer Initial)
5. The Buyer agrees to feed their Grace Golden only a premium quality food and keep their dog at a healthy weight.
6. The Buyer agrees to make and keep annual veterinary appointments for their Grace Golden and to keep all immunizations current according to their state guidelines of the AVMA and properly administer heart worm prevention.
7. The Buyer agrees to provide basic obedience training with their Grace Golden within the first year of life.
8. The Buyer agrees to postpone strenuous, repetitive exercise until after their Grace Golden is over two years of age.
9. The Buyer agrees to never place a Grace Golden dog in a shelter, pound or similar facility, or a research laboratory.
10. The Buyer agrees to communicate with the Seller on any updates of their Grace Golden. This would include veterinarian visits, weight/height, temperament, obedience training successes, and lots of pictures.
11. If the Buyer does not comply with the items listed above, the health warranty will be void and no refund will be offered.
_____(Buyer Initial)
12. The Buyer agrees that he/she understands this contract fully, and that this contract is under the jurisdiction of the State of Alabama, in the county of St. Clair. It is agreed the place of venue shall be in St. Clair County, Alabama.

The Seller and Buyer agree that this writing represents the entire agreement between them and that no other representations, either written or oral have been made regarding the dog.
